SOUTHEAST ALASKA COMMERCIAL GEODUCK FISHERY ANNOUNCEMENT

The following areas will be open for the commercial harvest of geoduck for live sale **from 8:00 a.m. to 4:00 p.m., Wednesday, January 12, and from 8:00 a.m. to 4:00 p.m., Thursday, January 13, 2022:**

Bucareli Bay and contiguous waters (Subdistrict 103-50-003): will be open for a remaining harvest of 5,000 pounds of geoduck;

Little Steamboat Bay (Subdistrict 103-70-002): will be open for a guideline harvest level of 15,400 pounds of geoduck.

Fishermen are reminded that unless otherwise specified, regulations regarding the geoduck fishery are stated in 5 AAC 38.142: Southeastern Alaska Geoduck Fishery Management Plan.

For a description of the above areas, please refer to the Southeast Alaska commercial geoduck fishery announcement dated September 17, 2021, announcing the open areas and their guideline harvest levels. All companies buying geoduck clams must contact the Fish and Game, Ketchikan office with a harvest report before **12:00 noon on Friday, January 14, 2022.**

State offices will be closed on Monday, January 17, 2022, in observance of Martin Luther King, Jr.'s Birthday.

The Emergency Order corresponding with this announcement is EO 1M0322.
